Synopsis: On February 15, 2026, at about 9:05 p.m., District 8 patrol responded to a shooting fronting Taco Bell in Kapolei.

The two male victims are part of group who are from the mainland. They are in Hawaii on contract work, had rented a gray 2022 Ford Explorer and were parked in the lot when an unknown male wearing all black and a black ski mask approached with a handgun and opened fire. Both victims were struck before the suspect fled on foot in an unknown direction.

The 40-year-old driver and the 42-year-old passenger were transported by EMS to a nearby hospital for treatment.

The suspect is described as a male, approximately 5'8", 160 pounds, wearing a black ski mask, black hoodie with a white stripe, and dark pants. He was armed with a black handgun.

No arrests have been made. The investigation is active.

UPDATE:

During the course of this investigation, Strategic Enforcement Detail (SED) detectives were assigned to further investigate. Numerous individuals were interviewed, hours of surveillance footage were reviewed, and evidence was recovered. As a result of the investigation, a 19-year-old male suspect was identified.

On February 18, 2026, at approximately 2:50 p.m., the 19-year-old male was arrested by the District 8 Crime Reduction Unit on Kakala Street in Kapolei for Attempted Murder in the 1st Degree, two (2) counts of Attempted Murder in the 2nd Degree, two (2) counts of Use of a Firearm in the Commission of a Separate Felony, and Place to Keep Firearm.

Additionally, at 3:45 p.m., a 16-year-old female who was with the 19-year-old male was arrested for Place to Keep Firearm. She was released pending further investigation.

Charges will be sought for with the Department of the Prosecuting Attorney.

UPDATE:

On February 20, 2026, at about 2:40 p.m., this case was conferred with the Department of the Prosecuting Attorney. The suspect, Keanu Wallace, was charged for Attempted Murder in the 1st Degree, two (2) counts of Attempted Murder in the 2nd Degree, two (2) counts of Use of a Firearm in the Commission of a Separate Felony, Place to Keep Firearm, and Possession of Prohibited Weapons (Ghost Gun). Bail was set at \$1 million aggregate.
