Synopsis: On May 30, 2026, District 4 Patrol officers responded to an assault investigation at Waialeale Beach, commonly known as "Dead Man's Curve."

Criminal Investigation Division Strategic Enforcement Detail (SED) detectives continued the investigation and determined that a 23-year-old man and a 15-year-old boy were assaulted by multiple individuals and sustained significant injuries requiring medical treatment. As detectives continued the investigation, it was learned that the victims were allegedly restrained and prevented from leaving during the assault. As a result, kidnapping offenses were added to the investigation.

On June 2, 2026, with assistance from District 4 and District 8 Crime Reduction Unit officers, three juvenile suspects were identified and arrested for Kidnapping and Assault offenses.

Today, June 3, 2026, two additional suspects, a 17-year-old male and a 15-year-old male, turned themselves in to District 4 and District 8 Crime Reduction Unit officers in Kaneohe. They were arrested for Kidnapping and Assault offenses in connection with the May 30, 2026 assault at Waialeale Beach, commonly known as "Dead Man's Curve."

UPDATE

Today, June 3, 2026, just after 6:30 p.m., this case was conferred with the Department of the Prosecuting Attorney. Petitions were filed in Family Court charging all five juvenile suspects with Attempted Assault in the First Degree.

Additionally, the two 17-year-old male suspects were also charged with Attempted Assault in the Second Degree.

UPDATE

Today, June 4, 2026, a sixth suspect, a 17-year-old male, turned himself in at the Main Police Station and was arrested by District 4 Crime Reduction Unit officers for Attempted Assault in the First Degree.

Later today, this case was conferred with the Department of the Prosecuting Attorney, and the 17-year-old suspect was charged. A petition was filed in Family Court for Attempted Assault in the First Degree.

Just before 7:30 p.m. this evening, a seventh suspect, a 19-year-old male, turned himself in to District 4 Crime Reduction Unit officers at the Kaneohe Police Station. He was arrested for Attempted Assault in the First Degree.

Charges will be sought with the Department of the Prosecuting Attorney for the 19-year-old suspect.

The investigation remains ongoing, and additional arrests are anticipated.
